The board of directors of the Company (the “**Board**”) announces the total production summary of Rension Project of Bluestone Mines Tasmania Joint Venture Pty Limited (the “**BMTJV**”) in which YT Parksong Australia Holding Pty Limited (“**YTPAH**”) owns 50% shareholdings, for the quarter from July to September 2021 (the “**Quarter**”). Physical outputs for the Quarter are summarised below with corresponding figures for the previous quarter (i.e. from April to June 2021):

Note: Recovery is expressed as overall recovery, taking account of losses of tin through the ore sorter and the concentrator.

Tin production for the quarter increased by 15.7% to 2,471 tonnes. The grade of ore mined for the quarter increased by 0.11 percent point to 1.5%. The average quarterly recoveries for the quarter increased by 1.6 percent points to 79.5%.
